

Appropriate Assessment Screening Determination under European Communities (Birds and Natural Habitats) Regulations, 2011 (as amended) for the Proposed Development of 62 noresidential units, a community facility, and associated works (Balally, Sandyford, Dublin 16)

As part of PPP (Public Private Partnership) Social Housing Bundle 5. The PPP programme is a partnership between the Department of Housing Local Government and Heritage (DHLGH), the NDFA and the local authorities involved. Dun Laoghaire-Rathdown County Council is proposing 62 no. residential units, a community facility, and associated works at Balally, Sandyford, Dublin 16.

## The project consists of:

- 62 no. apartment units in a 5-6 storey building over under-croft area
- 1 no. flexible community space of 249m²
- Energy Centre at sixth floor level and an external plant area set back at roof level
- Undercroft area at lower ground level comprising (a) 1 no. ESB substation (b) car and bicycle
  parking; (c) bin storage; (d) bulk storage area; and (e) supporting mechanical, electrical and
  water infrastructure.
- Landscaping works including provision of (a) communal open space; (b) new pedestrian and cycle connections linking Blackthorn Dive with Cedar Road; and (c) public realm area fronting onto Blackthorn Drive.
- All associated site development works including (a) vehicular access off Cedar Road; (b)
  pedestrian and cycle access off Blackthorn Drive; (c) public lighting; (d) varied site boundary
  treatment; and (e) temporary construction signage.

The total proposed site area is approx. 0.32 ha.

Inaccordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and Regulation 42(1) of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended Dun Laoghaire County Council caused NM Ecology Ltd. to undertake Appropriate Assessment screening to assess, inview of best scientific knowledge and the conservation objectives of the European Sites, if the proposed development, individually or in combination with other plans or projects Is likely to have a significant effection a European Site(s).

As required under Regulation 42(7) of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended, the County Council determines following screening that an Appropriate Assessment is not required.

No European sites are within the zone of influence of the proposed development. The proposed development is not directly, connected with or necessary to the management of any European site and it can be concluded on the basis of objective information, that the proposed development individually or in combination with other plans or projects is not likely to have a significant effect on the European sites identified and listed in the AAScreening Report prepared by NM Ecology Ltd.

The Council makes this determination based on the information and data supplied by NM Ecology Ltd - Consultant Ecologists including the Wintering Bird Survey as detailed in the Report. From the AA screening exercise undertaken the Council is satisfied having regard to:

• the nature and extent of the proposed works



- the distance between the proposed development site and designated conservation sites
- the lack of a direct hydrological pathway or biodiversity corridor link any European site
- the dilution, mixing and settlement effect of surface water within the drainage network, watercourses and in the marine environment
- the absence of any incombination effects from other projects in the vicinity of the proposed development

that the proposed development would not give rise to any significant effects on any European site through surface water, land and air, and groundwater pathways and that the construction and operation of the development will not impact on the conservation objectives of qualifying interests of European sites.

Having regard to the foregoing, on the basis of objective information and in view of best scientific knowledge and applying the precautionary principle, for the reasons set out above and in the AA Screening Report, it has been concluded that the proposed development (62 no. residential units, a community facility, and associated works) individually or in combination with other plans or projects, without relying on any mitigation measures, will not have a significant effect on any European Sites, in view of the sites' conservation objectives, and that there is no reasonable scientific doubt in relation to this conclusion.

Consequently, a Stage Two AA and a Natura Impact Statement (NIS) is not required.

The proposed development of 62 no. residential units, a community facility, and associated works is being promoted by Housing Department. This Appropriate Assessment Screening Determination in respect of the proposed Development of 62 no. residential units has been made by Aidan Blighe, Director of Services in the Planning and Economic Department to apply appropriate functional separation in the carrying out of a Screening Determination for Appropriate Assessment.
