

NOTICE OF PROPOSED DEVELOPMENT BY LOCAL AUTHORITY COMHAIRLE CHONTAE DHÚN LAOGHAIRE – RATH AN DÚIN DÚN LAOGHAIRE – RATHDOWN COUNTY COUNCIL

PLANNING AND DEVELOPMENT ACT, 2000 (AS AMENDED) AND PLANNING AND DEVELOPMENT REGULATIONS 2001 TO 2023 PROPOSED HOUSING DEVELOPMENT AT THE TOWNLAND OF BALALLY, BLACKTHORN DRIVE, SANDYFORD, DUBLIN 16 PC/H/01/2024

In accordance with Part 8, Article 81 of the Planning and Development Regulations, 2001 (as amended), Dún Laoghaire-Rathdown County Council hereby gives notice of a proposal as follows:

- 62 no. apartment units in a 5-6 storey building over undercroft area, including 31 no. one bed units; 21 no. two bed units; and 10 no. three bed units and 1 no. community facility of 249sqm; Energy Centre at sixth floor level and an external plant area set back at fifth floor roof level.
- Undercroft area at lower ground level comprising (a) 1 no. ESB substation (b) car and bicycle parking; (c) bin storage; (d) bulk storage area; and (e) supporting mechanical, electrical and water infrastructure; Landscaping works including provision of (a) communal open space; (b) new pedestrian and cycle connections linking Blackthorn Dive with Cedar Road; and (c) public realm area fronting onto Blackthorn Drive.
- All associated site development works including (a) vehicular access off Cedar Road; (b)
  pedestrian and cycle access off Blackthorn Drive; (c) public lighting; (d) varied site boundary
  treatment comprising walls and fencing; and (e) temporary construction signage.

In accordance with S.I. No.476/2011, Section 250, Planning and Development (Amendment) (No.3) Regulations, 2011 and S.I. No. 296/2018 European Union (Planning and Development) (Environmental Impact Assessment (EIA)) Regulations 2018, Appropriate Assessment Screening (AA) under the Habitats Directive (92/43/EEC) and the European Communities (Bird and Natural Habitats), Dún Laoghaire-Rathdown County Council has carried out screenings and has determined the following;

- An Appropriate Assessment has deemed that there are no likely significant adverse
  effects on the qualifying interests, special conservation interest or the conservation
  objectives of any designated European site. A determination has been made that an
  Appropriate Assessment is not required.
- There is no real likelihood of significant effects on the environment so therefore the preliminary assessment has concluded that an Environmental Impact Assessment Report is not required.

Any person may, <u>within 4 weeks from the date of this notice</u>, apply to An Bord Pleanála for an AA & EIA screening determination as to whether the development would be likely to have significant effects on the environment.

## Meath Se TD bows

Fianna Fáil senator Shane Cassells has said his decision to retire from politics came because he felt he had nothing more to contribute after spending 25 years in public life.

The 46-year-old Meath politician said he has been involved in politics as a councillor, Senator and TD since the age of 21. He will continue in the Seanad until the next general election, which must take place by March 2025, but will not contest it.

"I have done 16 years as a councillor and nine years in the Oireachtas as a TD and Senator," he said. "I'm out of public life now. I've really enjoyed it. It has been a privilege. But I'm done with public life."

Mr Cassells was expected to seek a nomination to stand the Meath West constituency in the general election to try to regain the seat he won in 2016 but lost in 2020. The other prominent
