had still not appeared on the agenda. that time, union sources said a meetg of the top brass in the public service as still set to go ahead at 10am today. The four top union negotiators were to brief leaders of 19 public secrunions on the state of the talks and hether they would continue, or there as a draft agreement or talks collapse. Union leaders had warned they would nalise arrangements for ballots for dustrial action if there are no proposls brokered before the meeting this norning. However, this will depend in the outcome of the talks.

Mr Callinan, who is chairperson of the rish Congress of Trade Unions public services committee and Fórsa general secretary, said the agenda for today's meeting will be kept under review.

The last public sector pay deal, Building Momentum, expired at the end of December. No agreement was reached at talks before Christmas.

Fresh discussions began on Tuesday after the WRC issued an invitation to the parties on Monday.

Mr Donohoe's officials have already given a guarantee to dismantle emergency legislation that unions claim has given his department too much power to reject their demands.

There has also been discussion of a union request for a mechanism to be set up to allow individual groups of staff to progress pay claims. They believe such claims are being thwarted because clauses in successive public sector pay deals have ruled out cost-increasing claims.

Under the last pay deal, public servants got a lpc pay rise in 2021 and 2pc in 2022. The agreement was later revised when unions argued that inflation was still increasing.

Another 3pc wage increase was backdated to February 2022 and there were pay rises of 2pc and 1.5pc this year.
