Dún Laoghaire-Rathdown County Council propose to upgrade the existing accommodation at St. Michael's Park, Monkstown Avenue, Co. Dublin from three no Caravan Bays to 3 no. two-storey houses and ancillary services. The existing day houses will be retained and incorporated into the footprint of the new houses. It will be necessary to temporarily re-house the tenants off the existing site to facilitate the works.
