#### 1 Introduction

This report which contains information required for the competent authority (in this instance Dún Laoghaire-Rathdown County Council) to undertake a screening exercise for Appropriate Assessment (AA), was prepared by Scott Cawley Ltd. on behalf of the applicant. It provides information on and assesses the potential for the proposed development to significantly affect Natura 2000 sites (hereafter "European sites").

It is necessary that the proposal has regard to Article 6 of the *Council Directive 92/43/EEC of 21 May 1992 on the Conservation of Natural Habitats and of Wild Fauna and Flora* (as amended) (hereafter "the Habitats Directive"). This is transposed in Ireland primarily by *the European Communities (Birds and Natural Habitats) Regulations 2011 (S.I. No. 477/2011)* (hereafter the Birds and Habitats Regulations) and the Planning and Development (Amendment) Act, 2010 as amended.

An AA is required if likely significant effects on European sites arising from a proposed development cannot be ruled out at the screening stage, either alone or in combination with other plans or projects.

Following the preparation of this screening statement it was objectively concluded that there was <u>no</u> <u>likelihood of any significant effects on any European sites arising from the proposed development, either alone or in combination with other plans or projects</u>. Therefore it was our view that an <u>Appropriate Assessment was not required in this instance</u>. The information in the tables below provide a summary of the information gathered for this screening exercise and the conclusions made.

### 2 Methodology

This Screening Statement for Appropriate Assessment was prepared with regard to the following guidance documents, where relevant:

- Appropriate Assessment of Plans and Projects in Ireland Guidance for Planning Authorities. (Department of Environment, Heritage and Local Government, 2010 revision).
- Appropriate Assessment under Article 6 of the Habitats Directive: Guidance for Planning Authorities. Circular NPW 1/10 & PSSP 2/10.
- Assessment of Plans and Projects Significantly Affecting Natura 2000 sites: Methodological Guidance on the Provisions of Article 6(3) and (4) of the Habitats Directive 92/43/EEC (European Commission Environment Directorate-General, 2001); hereafter referred to as the EC Article 6 Guidance Document. The guidance within this document provides a non-mandatory methodology for carrying out assessments required under Article 6(3) and (4) of the Habitats Directive.
- Managing Natura 2000 Sites: The Provisions of Article 6 of the Habitat's Directive 92/43/EEC (EC Environment Directorate-General, 2000a); hereafter referred to as MN2000.
- Guidance Document on Article 6(4) of the 'Habitats Directive' 92/43/EEC. Clarification of the Concepts of Alternative Solutions, Imperative Reasons of Overriding Public Interest, Compensatory Measures, Overall Coherence. Opinion of the European Commission (European Commission, January 2007).

The above referenced guidance sets out a staged process for carrying out Appropriate Assessment. To determine if Appropriate Assessment is required, documented screening is required. Screening identifies the likely effects on European sites, if any, which would arise from a proposed plan or project, either alone or in combination with other plans and projects.

If the conclusions at the end of screening are that there is no likelihood of significant effects occurring on any European sites, as a result of the proposed plan or project, either alone or in combination with other plans and projects, then there would be no requirement to undertake Appropriate Assessment.

However, even if screening makes a finding of no significant effects, and therefore concludes that Appropriate Assessment is not required, these findings must be clearly documented in order to provide transparency of decision-making, and to ensure the application of the 'precautionary principle'<sup>3</sup>.

Screening for Appropriate Assessment involves the following:

- Determining whether a project or plan is directly connected with or necessary to the conservation management of any European sites<sup>4</sup>;
- Describing the details of the project/plan proposals and other plans or projects that may cumulatively affect any European sites (see Table 1);
- Describing the characteristics of relevant European sites (Table 2); and
- Assessing the likelihood and significance of effects on relevant European sites (see Table 2).

The information that was collected to allow the competent authority to screen the proposal was based on a desktop study carried out on the 18<sup>th</sup> February 2016. Information relied upon included the following information sources, which included maps, ecological and water quality data:

- Ordnance Survey of Ireland mapping and aerial photography available from www.osi.ie;
- Online data available on European sites as held by the National Parks and Wildlife Service (NPWS) from www.npws.ie;
- Information on land-use zoning from the online mapping of the Department of the Environment, Community and Local Government <a href="http://www.myplan.ie/en/index.html">http://www.myplan.ie/en/index.html</a>;
- Information on water quality in the area available from www.epa.ie;
- Information on the Eastern River Basin District from www.wfdireland.ie;
- Information on soils, geology and hydrogeology in the area available from www.gsi.ie;
- Information on the location, nature and design of the proposed development supplied by the applicant's design team;
- Information on the status of EU protected habitats in Ireland (National Parks & Wildlife Service, 2013a & 2013b);

## Table 1 Overview of the Proposed Development and its Receiving Environment

#### **Brief Site Description**

The subject lands are located at the existing vacant Assistant Harbour Master's house located on 2 Queen Road in Dún Laoghaire Co. Dublin (Grid Reference: O 24648 28566). This area is a designated Architectural Conservation Area. According to the OSI Mapping Viewer, the proposed development site consists of the existing single-storey building, areas of hardstanding and some planted trees. The DART railway line is located c. 10m north of the proposed development site.

# Features of the Surrounding Environment

The desktop study found no records of any species or habitats for which European sites listed in Table 2 were designated within the subject lands or environs<sup>5</sup>. The following species (for which European sites listed in Table 2 were designated) were recorded within 2km of the proposed development site:

- Otter (Lutra lutra), recorded c. 1.3km north-west of the proposed development site at the West Pier in 2015;
- Oystercatcher (*Haematopus ostralegus*), Redshank (*Tringa totanus*) and Black-headed Gull (*Chroicocephalus ridibundus*), all recorded c. 40m east of the proposed development site in 2010;
- Teal (Anas crecca), recorded c. 1.4km west of the proposed development site in 2012;
- Curlew (Numerius arguata), recorded c. 220m north-west of the proposed development site in 2010;
- Roseate Tern (Sterna dougallii), recorded c. 600m east of the proposed development site in 2011;
- Common Tern (Sterna hirundo), recorded c. 145m east of the proposed development site in 2009;
- Arctic Tern (Sterna paradisaea), recorded c. 500m north of the proposed development site in 2001;
- Dunlin (Calidris alpina), recorded c. 1.3km north-west of the proposed development site in 2012; and,
- Light-bellied Brent Goose (Branta bernicla hrota), recorded c. 150m east of the proposed development site in 2010.

The proposed development site is located within the Coastal 08 river catchment. According to the EPA Envision Map Viewer, the nearest watercourse is the Monkstown Stream, located *c.* 1.4km south of the proposed development site. This stream is culverted for the majority of its course. Dublin Bay coastal waterbody is located *c.* 110m north of the proposed development site.

The groundwater body at the proposed development site is classified as 'Kilcullen' and is described as 'Poorly productive bedrock' and 'At risk of not achieving good status'. According to the GSI Map Viewer, the level of vulnerability to groundwater contamination from human activities is 'High'. It is described as 'Poor Aquifer – Bedrock which is generally unproductive except for Local Zones'. The bedrock of the area is classified as 'Granites and other Igneous Intrusive rocks'.

Foul effluent generated from the proposed development will be discharged to the existing sewer system, which is located on Queens Road. From there it will be transferred to Ringsend Wastewater Treatment Works (WWTW) for treatment prior to discharge into Dublin Bay. According to the EPA Envision Map Viewer Dublin Bay's coastal waters are "Unpolluted". Under the "Trophic Status Assessment Scheme" classification of the EPA, "Unpolluted" means there have been no breaches of the EPA's threshold values for nutrient enrichment, accelerated

	plant growth, or disturbance of the level of dissolved oxygen normally present (EPA, 2015). The most recent available water quality data for the Irish Sea indicates it is 'Unpolluted'
Description of the Proposed Development	In brief, the proposed development will involve alterations and renovations to the existing assistant Harbour Masters house located on Queens Road in Dún Laoghaire Co. Dublin. This vacant single-storey building will be converted into two separate residential one bed and two bed units. The estimated duration of the proposed development is approximately eight months. The Population Equivalent of the proposed development is 5 P.E.
	Surface water generated from the proposed development will be discharged to the existing combined sewer located on Queens Road. Foul effluent generated from the proposed development will be discharged to the existing sewer located on Queens Road. From there, it will be transferred to Ringsend WWTW to be treated prior to discharge into Dublin Bay.
Other existing or proposed	Existing habitat loss pressures
plans or projects nearby which may lead to cumulative effects on European sites.	The subject lands do not physically overlap with any European sites. They appear to be dominated by the existing building, hardstanding ground and some planted trees, none of which are habitats listed under Annex I of the Habitats Directive. These habitats are not indirectly connected with any habitats within European sites (e.g. by groundwater). No mobile fauna species for which European sites are designated are known to use the habitats within the subject lands. There is therefore no potential for cumulative effects relating to habitat loss.
	Existing pressures on water quality within European sites in proximity to the site
	Several intertidal habitats for which European Sites in Dublin Bay are designated are failing to meet favourable conservation status. For some of these, water pollution is considered to be a threat ranked as being of "high importance" (NPWS, 2013a).
	Pressures on European sites in Dublin Bay from surface waters
	There is potential for 'in-combination' effects of proposed plans and projects within the <i>Dublin City Development Plan 2011-2017</i> , draft <i>Dún Laoghaire-Rathdown County Development Plan 2016-2022</i> , <i>Fingal Development Plan 2011-2017</i> and other county level land use plans which can influence conditions in Dublin Bay via rivers and other surface water features. Dublin Bay is of 'Unpolluted' water quality status and the pollutant content of future surface water discharges to the Bay is considered likely to be decreased in the long-term. This is because it is an objective of the Greater Dublin Strategic Drainage Study, and all development plans within the catchment of Ringsend WWTW to include Sustainable Urban Drainage Systems in new development. Together these objectives are considered likely to reduce pressures on designated marine and intertidal species and habitats in Dublin Bay.
	Other planning applications in the surrounding area

# Table 1 Overview of the Proposed Development and its Receiving Environment

In the draft Dún Laoghaire-Rathdown County Development Plan 2016 – 2022, the proposed development site is zoned as 'Objective F – To preserve and provide for open space with ancillary active recreational amenities'. The lands in the vicinity of the proposed development site are zoned as 'Objective MTC – To protect, provide for and-or improve major town centre facilities' and 'Objective W – To provide for waterfront development and harbor related uses'.

Given the urban nature and zoning objectives of the area, there is likely to be a number of planning applications within the zone of influence of the project which have the potential to produce 'in combination' effects on water quality in Dublin Bay if the construction of these projects was to coincide with the construction phase of the proposed development. However, the likelihood of impacts arising from the proposed development is deemed to be low due to the minimal scale of the proposed works, the urban land buffer between the site from Dublin Bay (i.e. c. 110m) as well as the nature, scale and temporary duration (i.e. eight months) of the proposed works. No impacts are predicted during the operational phase of the proposed development, as neither foul effluent nor surface water runoff will be generated.

Conclusion for potential in-combination effects from surface waters during construction phase

It is our professional opinion that there will be no likelihood of significant effects on any European sites during the construction or operation of the proposed development, in combination with other plans or projects. This judgement was reached on the basis that:

- The coastal waters in Dublin Bay are classed as 'Unpolluted' by the EPA;
- It is an objective of all development plans within the catchment of Ringsend WWTW to include Sustainable Urban Drainage Systems for all new developments;
- Irish Water has recently advertised for "the provision of a biological secondary treatment process that will result in the expansion of the existing Ringsend WWTW by a Population Equivalent of 400,000".
- In the unlikely event of a pollution event occurring during construction, this would not be of such a magnitude that it would have a significant adverse effect on water quality in Dublin Bay.




Figure 1. All European sites within 15km of the site

European sites within 1km, 5km and 15km of the proposed development site are shown in Figure 1 overleaf.

# 3 Conclusions of the Screening Assessment

Following an examination, analysis and evaluation of the relevant information including, in particular, the nature of the proposed development and the potential relationship between the proposed development and relevant European sites and, applying the precautionary principle, it is the professional opinion of the authors of this report that there will be no likelihood of significant effects on any European sites, arising either from the proposed development alone or in combination with other plans or projects.

Therefore it is our view that an Appropriate Assessment is not required for the works proposed.
