Data Protection PRIVACY STATEMENT for processing of personal data contained in submissions made during the public engagement Process for Dundrum By Design Community Voting

Who we are and why do we require your information?

Dún Laoghaire – Rathdown County Council (“the Council”) seeks to promote the economic, social, and cultural development of the County of Dún Laoghaire – Rathdown and in doing so contribute significantly to improving the quality of life of the people of the County. The delivery of high-quality services, tailored to meet the needs of all our customers, remains one of the Council’s core objectives and is included in our Corporate Plan. In order to provide the most effective and targeted range of services to meet the needs of the citizens, communities, and businesses of the County of Dún Laoghaire Rathdown, we will be required to collect, process, and use certain types of information about people and organisations. Depending on the service being used, the information sought may include ‘personal data’ as defined by the Data Protection Acts and by the General Data Protection Regulation (GDPR) and may relate to current, past, and future service users, past, current, and prospective employees/suppliers, and members of the public who may engage in communications with our staff. In addition, staff may be required, from time to time, to collect, process and use certain types of personal data to comply with regulatory or legislative requirements.

The Council is working with the **UCD’s School of Architecture and Environmental Policy** on this project.

Why do we have a privacy statement?

This privacy statement has been created to demonstrate our commitment to privacy and to assure you that in all your dealings with the Council, we will ensure the security of the data you provide to us. The Council creates, collects, and processes a significant amount of personal data in various multiple formats daily. The Council’s commitment to you is that the personal data you may be required to supply to us is:

- Obtained lawfully, fairly and in a transparent manner.
- Obtained for only specified, explicit and legitimate purposes.

- Adequate, relevant, and limited to what is necessary for purpose for which it was obtained.
- Recorded, stored accurately, securely, and where necessary kept up to date.
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Kept in a form which permits identification of the data subject.
- Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

What is the activity referred to in this Privacy Statement?

This statement refers to the processing of personal data in respect to details collected to provided us with information on the people/organisations who are participating in the community voting on a range of proposals illustrating how the Town and Living Streets Dundrum Scheme areas could be developed in the future.

Participants will have the opportunity to review and vote on each proposal. You can vote on each proposal using your phone, tablet, or computer.

The survey information collected is to provide information on the respondents these include: your interest in the project, where you are located, gender and age.

What is the basis for making the processing of this personal data lawful?

Processing is necessary for compliance with a legal obligation to which Dún Laoghaire-Rathdown County Council is subject in accordance with Article 6 (1)(c) of the GDPR.

What types of personal data is required in this process?

A person's name and contact details (email /or postal address) are the only requirement to make a submission.

Providing an email address will allow receipt of a submission to be sent.

Your name, address or any other detail collected will not be shared with a third party or used for any other purpose.

What will happen if your name and address/email is not provided?

Failure to provide your name and postal address or email address will result in Dún Laoghaire – Rathdown County Council being unable to process your submission.

What other types of personal data do we need to undertake this activity?

None.

Am I the only source of this personal data?

In some instances, to assist with the delivery of the activity or to comply with regulatory or legislative requirements personal data is sourced from a third party.

This **DOES NOT APPLY** to this activity.

Is personal data submitted as part of this activity shared with other organisations?

The Council may, to fulfil statutory or regulatory obligations or in the public interest, from time to time, have to share personal data with other organisations or entities (in Ireland or abroad). Where this is required, the Council shall have regard to your rights, to the security and integrity of the data and will minimise the data shared.

Sharing **DOES NOT APPLY** to this activity.

How long is my data kept for?

The Local Authority sector operates under a detailed record retention policy which outlines time periods for which your personal data will be retained and what will happen to it after the required retention period has expired. Do you need to update your records?

Dún Laoghaire – Rathdown County Council must take reasonable steps to ensure that the personal data we have about our customers is correct and up to date. In addition, if the data held by us is found to be inaccurate you have the right to rectify/correct this. If you find that personal data, we have about you is inaccurate or needs to be updated (for instance, you may have changed your name, address, contact details etc.) then please contact us so that we can correct it. Your Rights

You have the right to request access to personal data held about you, obtain confirmation as to whether data concerning you exists, be informed of the content and source of data, and check its accuracy. In addition, if the data held by us is found to be inaccurate you have the right to change, remove, block, or object to the use of, personal data held by the Council. In certain circumstances blocking access to data may delay or remove access to a service where the data is required by law or for essential purposes related to delivery of a service to you. Please note that to help protect your privacy, we take steps to verify your

identity before granting access to personal data. To exercise these rights, you should take the following steps,
