1. Introduction

This report has been prepared by Connect the Dots on behalf of Parks & Landscapes Services, Dún Laoghaire Rathdown County Council. It provides an overview of official submissions received during the Part VIII consultation period on Phase 1 Plans for Shanganagh Park, that ran from 6th April 2023 to 22nd May 2023 inclusive. It is intended to be included in the Chief Executive Report prepared by Parks & Landscape Services under statutory Part VIII requirements. This report is an independent and impartial analysis of the received submissions.

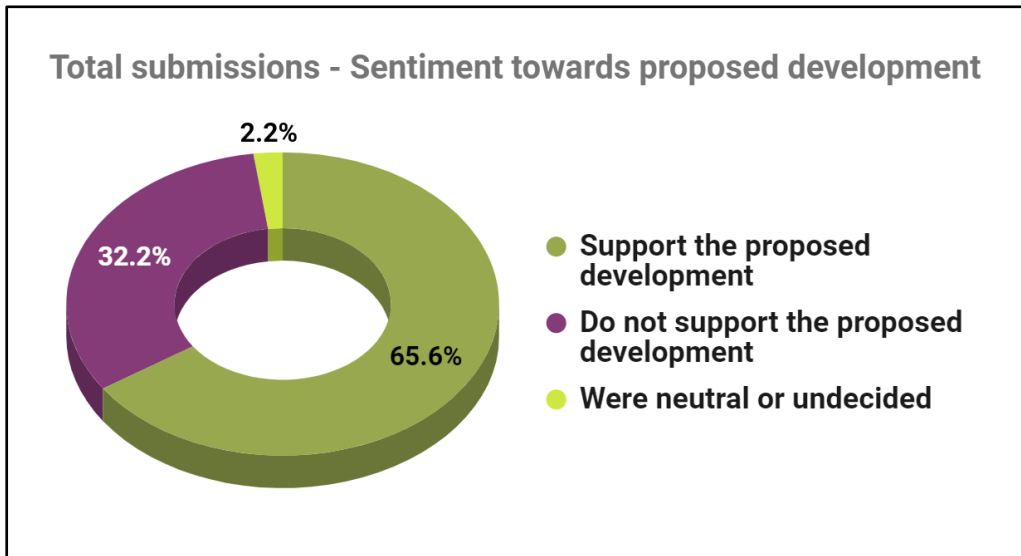
During the outlined consultation period, Connect the Dots facilitated two information webinars intended to give the local community an opportunity to ask questions about the latest plans and to inform them on how they could make a formal submission. The first of these webinars was a mixed session for local residents and sports club members, held on Tuesday 18th April 2023. Stakeholders from both groups who had participated in previous pre-Part 8 workshops were initially invited via email, and were encouraged to invite other interested individuals. The second webinar was open to the general public, held on Wednesday 26th April 2023. This webinar was widely promoted across dlr's website and social media channels, via email, posters in local community spaces and in Shanganagh Park itself, and flyers dropped to households in the wider Shankill area.

This consultation activity followed on from a period of pre-Part 8 consultation on Phase 1 plans in February 2023, the outcomes of which can be found [here](#).

2. Summary of Part 8 Submissions

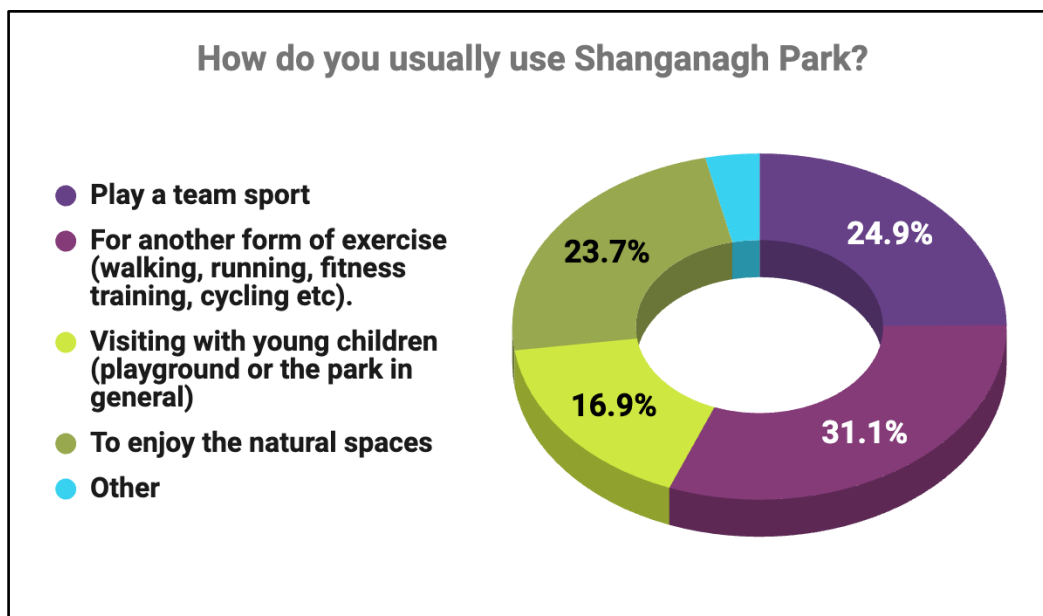
A total of 1137 submissions were received during the stipulated time period. 30 of these submissions were discounted as duplicates (ie. if both the name and email address matched another submission. Where duplicates occurred across an online survey and email submission, the contents of the email submission were used for data analysis). With this accounted for, 1032 submissions were analysed from the online survey, 73 were analysed from email and 2 were analysed from postal submissions. A table of the full list of people who made a submission through each channel can be found in Appendices 7.1 - 7.3.

Of the 1107 valid responses received, **726 support** the proposed development, **357 do not support** the proposed development, **24** were **neutral or undecided** in their opinion. A further breakdown of these figures is included in the following sections.



2.1 Online Survey Submissions Overview

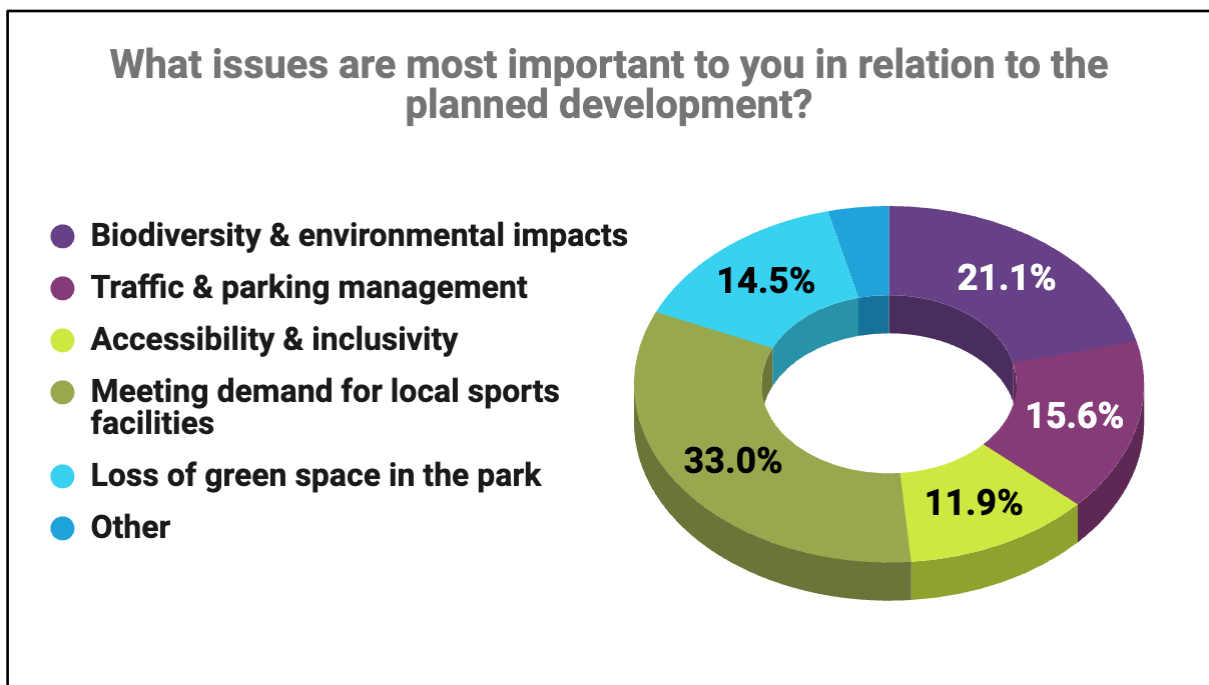
A survey was hosted on the dlr Citizen Space website during the consultation period, with questions designed to make it easy for people to share their thoughts in a direct and accessible manner. Respondents were first asked how they typically use Shanganagh Park. The below chart reflects the total percentages of options selected, including respondents who chose multiple options.





Among the remaining percentage of answers that chose *Other* (3.4%) many reiterated and expanded on the pre-defined options. Additional uses for Shanganagh Park that were submitted included for Dog Walking/the Dog Park, for Peace & Mindfulness/Meditation, for Socialising, to use the Open Space, for Hobbies (bird watching, rollerblading, photography etc.), for Mental Health purposes, to Access the beach and for Patrol (safeguarding & cleaning).

Based on concerns raised during pre-Part 8 consultations, a number of issues were presented as choices for what is most important to respondents in relation to the planned development. The below chart reflects the total percentages of options selected, including respondents who chose multiple options.



Other specific issues that were submitted included concerns about the impact of floodlights/lighting, impact of increased park visitors on nearby residents, mental health impacts of loss of green space, safety issues in the park and mistrust and frustration around the consultation process.

Respondents were given the choice to share any group associations they had. For those who supported the plans and shared this information, a majority identified as members of local sports clubs, as well as many local residents and private individuals. For those who did not support the



plans and shared this information, a majority were local residents or private individuals, with a smaller number of sports club members.

Respondents were given three options when selecting their overall opinion on the proposed development. The below chart shows the percentage of respondents who chose each option. Of the **1,032** valid survey respondents, *714 support* the proposed development, *295 do not support* the proposed development and *23 are undecided/neutral* in their opinion.

2.2 Email Submissions Overview

Email submissions were received via parksconsultations@dlrcoco.ie and a total of 73 valid responses were collected. Of these responses, most were made by individuals who either identified themselves as a local resident or had not specified a particular group/organisation. 5 responses were made by sports club members and 2 were representatives of local resident groups.

Of the 73 valid email submissions, 60 opposed the development plan, 12 supported the plan and 1 was a neutral submission giving recommendations. Many of the submissions opposing the plan followed a templated response, a copy of which can be found in Appendix 7.4.

2.3 In person Submissions Overview

Two postal submissions were received, both submitted by local residents who were not in support of the development plans. One submission was a copy of the templated response found in Appendix 7.4.



3. Support for the plans

The online survey provided the opportunity for respondents to share any elements of the proposed plan that they believed were positive additions to the park. These responses were combined with email submissions outlining their support for the plans. Below are summarised relevant themes that were commonly referenced among all submissions in support of the plans.



Increased Access to Sports Facilities

The addition of floodlit pitches and additional lighting (167) in the park was most commonly mentioned as a positive aspect of the plan. It was noted that the floodlighting would extend the hours of play for sports and activities, especially on winter evenings. This would be of benefit to local sports clubs as there is currently a lack of floodlit facilities in the DLR area. These additions would also make the park feel safer for pedestrians/walkers/joggers using shortcuts on darker days and for children to play.

The addition of a pitch that can be used all year round (50) was also viewed as a positive, as currently many sports and outdoor activities are cancelled due to the unsuitability of existing facilities in bad weather conditions.

“Such a waste of a fantastic space when it can not be used for sports due to bad weather and unfit pitches. Disappointed teams and clubs with matches cancelled.”

“I believe it will benefit both local community and local sports clubs by offering badly needed additional services by having all weather facility and entice locals to get more active with all year round facilities”

“Floodlights would greatly increase the park's accessibility during the winter months and create a safer space for solo exercisers on darker evenings.”



Meeting demand for Sports Facilities

Sports club respondents in particular highlighted that additional pitch facilities (105) would meet the demands (43) of a growing community with an interest in sport. The running track addition (81) was also noted as a positive as it would provide all year round benefits for local running and athletics groups. These groups currently have no training facilities, which are essential for the continued development of youth and adult athletes in the area.



Providing facilities for the wide variety of activities and community groups lacking in training spaces will allow groups to further grow, therefore these developments would be increasingly beneficial in the long term. These facilities would not only benefit the current generation but also future generations in encouraging sports participation. The positive impact it would have on keeping girls involved in sport was also noted.

“With the current development underway in the area the pitch will be critical to the sporting participation of a growing generation of kids who live or will soon live in the area. Pitches in the DLR area are in short supply and the population from Cherrywood to Bray deserves such facilities.”

“The provision of sporting amenities is crucial as the local population expands for the overall well-being of the community”

“I particularly welcome the proposed sprint track and long jump pit as it will greatly enhance the amount and variety of training that my clubmates and I can do in the park. We have a very active juvenile section in our club and they will find the track etc. extremely useful as well”



Impacts on Young People

Additional facilities would encourage young people to be more active, positively impacting their wellbeing and reducing anti-social behaviour (69). These plans also meet the demands of the rapidly growing community of children and young people in the area and the lack of playing facilities. Providing facilities will nurture young sports players and their engagement with the community, through cultural inclusive growth and through the physical and mental health benefits of exercise and outdoor activity.

“The creation of this “active recreation zone” will support positive growth of children within the area.”

“Increased sports facilities will give a wider spread of people an opportunity to benefit from the park. Young people in particular, as this age cohort tend to be more involved in team activities and consider walking a form of transport rather than recreation.”



Community Health & Wellbeing



It was noted that space for additional sports and activities would have a positive impact on the local community as a whole, encouraging fitness for all ages (62). The entire local community can be inspired to use the facilities which promote healthy living (35) and give more social opportunities.

Development of the park is necessary for not only "clubs" but for everyone exercising or getting out of the house for their mental well being. It will bring a lot more diversity to the park for all to enjoy.

"... it encourages parents and guardians and other family members to utilise other amenities in the park (walking, running dog park etc.)"

Other Positives

- The planting of more trees, the retention of a portion of the central meadow and the improvement of other green spaces for biodiversity and nature (19)
- The combination of passive and recreational activity through the addition of sports (12)
- The upgrading and maintenance of the existing pitches to be brought up to higher standard and facilitate increased usage. (12)
- Creating a safer space and atmosphere in the park for all (8)



4. Non-Support for the plans

The survey also provided the opportunity for respondents to share any elements of the proposed plan that they believed were negative additions to the park. These responses were combined with email and postal submissions who outlined their lack of support for the plans. Below are summarised relevant themes that were commonly referenced among all submissions that did not support the plans.



Traffic & Parking

Local residents are already unhappy with the frequent congestion caused by cars parked in residential areas during peak sports times. Due to the distance between the proposed development and the car park, concerns were raised by residents that more people will continue to park in the housing estates, making existing traffic and parking issues worse (144). A repeated request was made for a new Traffic Management Report to be prepared that measured peak times and had more specific actions to solve parking and traffic issues (4). There were mixed views on the role of paid parking in nearby estates as a potential solution.

“Parking has not been given due consideration which is a huge oversight. Additional parking facilities need to be incorporated into the phase 1 plans or nearby estates are going to come under pressure. People will park in them to get closer access to the facilities they are using. This is also potentially dangerous for our children who are playing in the estates and soon there will be an influx of cars at busy times”

“Increased traffic congestion on St Annes Park - it is crowded enough already, any increase in traffic and parking will be a disaster for residents”

“BEFORE THIS PROPOSAL IS EVEN CONSIDERED A FINITE DETAILED TRAFFIC MANAGEMENT PLAN NEEDS TO BE PRODUCED to clearly demonstrate how parking and traffic flow will be addressed to the satisfaction of ALL.”



Loss of meadow/green space

Most submissions that were not in support of the development plans were unhappy with the proposed loss of the meadow/green space (150). This space is well loved and well used by the local community for passive recreation. Many

strongly emphasised their preference for upgrading the current front pitches instead of removing this natural space. Many expressed frustration with the previous loss of green space to Woodbrook Golf Club (15) and would like to avoid the same thing happening. Some respondents felt the current level of sports facilities in the Shankill area is sufficient and additional facilities would be excessive (83). Others understood the need for these facilities but would prefer to see existing sports facilities in the area upgraded or expanded, such as at Stonebridge, Shanganagh Cliffs, Woodbrook College, Cherrywood (85). The importance of maintaining green spaces in the context of a rapidly growing and increasingly built up area was emphasised. Suggestions were also made for additional land to be purchased to expand the footprint of the park.

“Loss of natural habitat and a natural area for people to enjoy. Replacing a rare public space of natural beauty and biodiversity in this day and age beggars belief.”

“Instead of a free open space, which already includes several playing pitches, the proposed change will effectively turn the park into a sports ground. I have no objection to sport per se but it seems to me that there is already ample space and concession given to those who do want to play sport.”

“I would prefer to see the existing sport's facilities upgraded rather than the meadowland being converted into pitches for organised sports to the detriment of the natural environment. It would also be a loss of a green space for those of us who wish to walk, play with grandchildren and generally enjoy the park.”

Biodiversity concerns



Respondents noted that the loss of green space would not just impact park visitors, but also the wildlife and biodiversity in the park (98). It was noted that the park is currently home to a variety of flora and fauna, and that such spaces for wildlife are increasingly under threat due to development in the Shankill area. Many respondents noted DLRCC's Climate Emergency declaration and their belief that these plans go against that commitment. The need for an Environmental Impact Assessment that considers the cumulative impact of development in the immediate area of Shanganagh Park was also strongly suggested.

“Biodiversity - which was there before we humans came along - is going to be impacted, at a time when environmental protection has become a massive global issue. We can at least preserve the local wildlife accessible areas.”

“Loss of green natural space for birds, foxes, squirrels, wildlife”



“Destroying what’s left of any wild areas in the area and disturbing important habitat for sand martins and pipistrelle bats.”



Light, noise and other pollution

The floodlights were also labelled as intrusive to local residents. Concerns over light pollution and brightness levels interfering with nature were also commonly referenced (105). The additional playable hours the floodlights would bring would increase human activity in the park, which is likely to have biodiversity consequences for the nearby flora and fauna. It may also have a negative impact on the peace in the park during the evenings. Along with light pollution, the additional noise and litter that increased volumes of visitors to the park would bring was noted as a concern (29).

“I am objecting to the proposed development plan to install a new pitch in the area known as the meadow especially with the flood lights which will be detrimental to those living in the two neighbouring estates.”

“Adding floodlighting will disturb the animals that live there.”

“creating a noisy environment where peace and tranquility exists at the moment”

Other

- Anti social behaviour (14) - concern that lighting would encourage anti social behaviour in the park later into the night, closer to residential areas.
- Overdevelopment of Shankill (27) - general concern for how quickly Shankill is developing without holistic thinking on provision of necessary services and spaces for future populations.
- Health (mental & physical) impacts (10) - prioritising health benefits of organised sports over more passive benefits of green spaces.
- Construction disruption (3) - concerns that construction of the proposed facilities would block access to the park, disturb nearby residents and damage natural environment in the park.
- Duck pond (21) - many wanted the duck pond/wetlands removed from the plan. Reasons included feeling it was a redundant addition and concerns about child safety around open body of water.
- Combined cricket/baseball facilities (3) - a number of submissions wanted these facilities to remain separate. During busy summer months, schedules for both games may clash.
- Age friendly/accessibility (5) - current meadow area is most accessible for less mobile visitors. New plans are not as accessible.

Of the 61 email submissions that were against the development plan, 23 followed a templated response (see Appendix 7.4). This template response opposed the development plan and requested that the council respect community wishes and stakeholder feedback. Key requests in these submissions were to avoid development in the meadow due to its importance in passive recreation, mental health, well being, habitat preservation and biodiversity. Specific requests included to upgrade the existing pitches in Shanganagh Park, Stonebridge, Shanganagh Cliffs, Woodbrook College, to revise a post-Covid Masterplan for Shanganagh Park, to undertake an Environmental Impact Assessment and to explore opportunities to purchase nearby and adjacent land and expand the park footprint.

5. Additional Facilities and Services

Online survey respondents were asked if there were additional facilities or services they would like to see in Shanganagh Park. Frequent suggestions that have not already been references above include:

- Toilets (105)
- Changing room facilities (62)
- Bins (40)
- Better walking/running/cycling routes in the park, including a nature trail (23) - many suggested that these trails could include information boards on the park's biodiversity
- Seating & picnic benches (39)
- Additional tree planting and other biodiversity measures (36) such as beehives and native trees
- Café (27)
- Upgraded playground (22)
- Drinking water fountain (19)
- Better dog facilities (17) - improved facilities in the dog park, split between big and small dogs
- Bike facilities (13), including shared bike schemes and storage
- Better lighting (14)
- Community spaces (10) and event spaces (7) - including a community hall, bandstand area, farmers markets
- More staff in the park (6) - particularly dog, litter and parking wardens



184 respondents requested additional sports facilities. In addition to the facilities already proposed in the plans, requests were made for

- Additional pitches (71), specifically astro pitch (21)
- Skate park (28)
- Longer running tracks (28), particularly a 400m track
- BMX facilities (8) and pump track (15)
- Hurling wall (12) and handball alley (3)
- Storage facilities for various sports (5)

6. General comments

The final section of the survey allowed people to make general comments in relation to the plan. These comments were combined with general comments made across email and postal submissions. Many of these comments reflected the same views as already covered in previous sections. A selection of relevant comments have been included below, that reflect some of the general sentiments expressed across all submissions.

Support plans

“I feel that the campaign against the proposal that has been organised by a small group of local residents does not represent the views of many in the local community and it would be very regrettable if a small but vocal group of residents could prevent the improvement of the park for local residents and visitors alike.”

“I do believe that some online campaigns against the re-development of the park have misinformed the public and have overstated potential issues - which is unfortunate. I think the implementation of the plans would be a tremendous asset to the area.”

“I encourage DLR to progress this project as quickly as possible, as even if it does not suit everyone, or all of my preferences; it is far better to be making the investment now.”

Do not support plans

“DLR Council has not provided a single convincing argument why a new sports pitch should be placed in the middle of the park when lots of other spaces are

available which could be upgraded (existing pitches; pitches in Stonebridge Road). The decision to ignore both local concerns and the conclusions provided by Connecting the Dots makes me doubt in the the Council's commitment to listen to citizen's voices."

"Spending considerable resources to redevelop an already diminishing resource will have a very small net-return on the investment. Yes, there'll be an additional facility, but at the same time, it is taking away precious facilities for local residents - quiet, undeveloped spaces which are an oasis in these busy and hard times. EXPAND the available community resources (in line with the expanding local population) and you will have my support, and no doubt, from many in the local community."

"The online petition at www.change.org/SaveShanganaghPark has garnered almost 2,100 signatories from community members and park visitors from near and far."

Suggestions for progression of Phase 1 development

"I understand that some compromise is needed and I AM willing to pass on wholeheartedly opposing the plans. However, the floodlights are a remaining big issue, and as long as they stay I think a lot of local residents will be very angry about these plans."

"My observation is that the existing pitches are underused. Simple time organisation might help to get more club members enjoying the sport activities by better time planning."

"As a resident of Shankill, I believe it would land a lot easier with residents if a priority or sizable percentage of of access to the "new pitch" was given to sports club(s) who can clearly evidence, by percentage of memberships, that they can walk, run or cycle to the park (e.g: % members who live within a 1-2km radius of the facility, therefore reduced traffic and parking on the community)."

"Should this go-ahead. I would like to see guarantees that the remaining meadow space will not be damaged or used as accessways throughout the construction phase of the MUGA's. If this Council is serious about minimising it's environmental impact then it's essential that the woodlands are left in their natural state as much as possible to not impact local bio-diversity."



Alternative locations for sport in the area

Suggestions were also made in this section for additional locations for sports facilities.

- Make one of the new Cherrywood pitches available on a temporary/emergency basis.
- Repurpose crematorium site for sport
- Relocate sports to field beside Shankill DART Station
- Acquire fields adjacent to and nearby park to expand (Allies River Road and Clontra)

Dear Parks Department,

I OPPOSE the current plans for Shanganagh Park and request that the Council respect community wishes and stakeholder feedback by:

- *Avoiding any development of sports facilities in the central field covered by these plans due to identified but inadequately remedied and significant issues including traffic management, the area's importance for accessible passive recreation, mental health and well being outside of sport participation, habitat preservation and natural character of an open green space managed for biodiversity*
- *Upgrading existing facilities in Shanganagh Park, Stonebridge, Shanganagh Cliffs, Woodbrook College etc. to improve playability*
