Proposed development at Kilbogget Park Athletics Track and Soccer Pitch comprising the installation of 2no. 18.29m and 4no. 21.34m high galvanised floodlighting columns, fitted with LED luminaires, to include all associated civil and electrical works, and all ancillary works at Kilbogget Park.

In accordance with Article 42(1) of the European Communities (Birds and Natural Habitats) Regulations 2011-2021, the Planning and Development Acts 2000-2022, Article 120(1B)(i) of the Planning and Development Regulations 2001-2022 and the European Union (Planning and Development) (Environmental Impact Assessment) Regulations 2018 Dún Laoghaire-Rathdown County Council has made determinations following screening that:
