

DRAFT COUNTY DEVELOPMENT PLAN 2016-2022 NOTICE OF PROPOSED AMENDMENTS

In accordance with Section 12 [7] of the Planning & Development Act, 2000 (as amended) (and Regulations made thereunder) notice is hereby given of the preparation of Proposed **Amendments** to the Dún Laoghaire-Rathdown County Council Draft County Development Plan 2016-2022.

In accordance with Section 12(7)(ab) of the Planning and Development Act 2000 (as amended), the Chief Executive made a determination that a Strategic Environmental Assessment and Appropriate Assessment are required to be carried out for certain of the proposed material amendments (Chief Executive's Order No. P.Gen 31/15).
