

# PREPARATION OF A LOCAL AREA PLAN FOR DUNDRUM 2019 – 2025 PLANNING AND DEVELOPMENT ACT, 2000, (AS AMENDED) PLANNING AND DEVELOPMENT (STRATEGIC ENVIRONMENTAL ASSESSMENT) REGULATIONS 2004, HABITATS DIRECTIVE 92/43/EEC

Notice is hereby given, pursuant to Section 20 of the Planning and Development Act, 2000 (as amended), that Dún Laoghaire-Rathdown County Council, being the Planning Authority for the County, intends to prepare a Local Area Plan for the following area:

Dundrum

The preparation of the Local Area Plan has two phases: A Pre-Draft and Draft phase. Presently we are at the 'pre-draft' stage which is followed by the preparation and publication of a Draft LAP. At both stages the planning authority undertakes public consultation exercises and invites your comments. The County Council hereby invites any interested parties or individuals to make suggestions or forward ideas in advance of the preparation of the Draft Local Area Plan. Submissions may be made during the period from Monday 19th November 2018 to Friday 14th December, 2018.

## **Strategic Environment Assessment and Appropriate Assessment**

In compliance with the Strategic Environmental Assessment Directive (2001/42/EC) and in accordance with Article 14A of the Planning and Development (Strategic Environmental Assessment) Regulations 2004 (S.I. No. 436 of 2004) (as amended), the Planning Authority proposes to carry out a Strategic Environmental Assessment (SEA) (Screening Report) as part of the preparation of the Local Area Plan.

Pursuant to the requirements of Article 6 of the Habitats Directive (92/43/EEC), a Stage One Appropriate Assessment Screening shall also be carried out as part of the overall process and a Stage Two Appropriate Assessment (AA) shall subsequently be carried out, if required.

A 'PreDraft Issues Paper', which sets out the background context for preparing the Local Area Plan and identifies the topics that may be included in a Local Area Plan, together with a map identifying the area for which the Plan will be prepared, may be inspected at the following locations:-
