

PLANNING AND DEVELOPMENT ACT 2000 (AS AMENDED) DRAFT LOCAL AREA PLAN FOR KILTIERNAN – GLENAMUCK. 2025

Notice is hereby given, pursuant to Section 20(3) of the Planning and Development Act 2000 (as amended), that Dún Laoghaire-Rathdown County Council, being the Planning Authority for the County, proposes to make a Local Area Plan for Kiltiernan - Glenamuck.

In complying with the Strategic Environmental Assessment Directive (2001/42/EC) and the Planning and Development (Strategic Environmental Assessment) Regulations, 2004 (as amended), Dún Laoghaire-Rathdown County Council has on foot of the current population of the Plan area, determined that a Strategic Environmental Assessment is required. It has also been determined that an Appropriate Assessment, pursuant to Article 6 (3) of the Habitats Directive 92/43/EEC and the European Communities (Birds & Natural Habitats) Regulations 2011, (as amended) is required.
