

PLANNING AND DEVELOPMENT ACT 2000 (AS AMENDED) PROPOSED MATERIAL ALTERATIONS TO THE DRAFT OLD CONNAUGHT LOCAL AREA PLAN 2025

Notice under Section 20(3) of the Planning and Development Act 2000 (as amended)

Notice is hereby given, that the Elected Members of Dún Laoghaire Rathdown County Council having considered the Draft Old Connaught Local Area Plan 2025 and the Chief Executive's Report in respect of submissions/observations received, have resolved in accordance with Section 20(3)(e) of the Planning & Development Act 2000 (as amended), that Dún Laoghaire-Rathdown County Council, being the Planning Authority of the County of Dún Laoghaire-Rathdown, proposes to make material alterations to the Draft Old Connaught Local Area Plan 2025.

In accordance with Section 20(3)(f) of the Planning and Development Act 2000 (as amended), Dún Laoghaire Rathdown County Council has screened the proposed material alterations for the need to undertake a Strategic Environmental Assessment (SEA) and an Appropriate Assessment (AA) and has determined that an SEA is required with respect to certain proposed material alterations and a Stage 2 AA is not required for any proposed material alteration.

A copy of the proposed material alterations to the Draft Old Connaught Local Area Plan 2025, the SEA and AA Screening Determinations in accordance with Section 20 of the Planning and Development Act, as amended, and associated SEA and AA documents (including information on the likely significant effects on the environment of implementing the proposed material alterations that is included in the SEA Environmental Report on proposed material alterations), will be available for inspection from Monday to Friday (excluding Bank Holidays) from Friday, 25th July 2025 to Friday, 22nd August 2025 inclusive at the following locations:
