**NOTICE OF PROPOSED DEVELOPMENT**

In accordance with the above regulations Meath County Council proposes to carry out the following development located at Staleen, Donore, Co. Meath:

The development will consist of a development of 21 housing units in total, including all site development works, with vehicular access through the existing development at Staleen (An Riasc), and a pedestrian access through the existing Saint Mary's Villas development.

**The proposed housing units will comprise;**

- 6 no. 1 bed single storey houses
- 13 no. 2 bed two storey houses
- 2 no. 3 bed two storey houses

The plans and particulars of the proposed development will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy during office hours at the offices of the Local Authority, from 21/2/2019 to 22/3/2019.

Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.
