

Dun Laoghaire Rathdown County Council (DLRCC), in conjunction with the National Transport Authority (NTA) are working with AECOM consulting engineers on a design to facilitate BusConnects Service upgrade to the bus network in Dun Laoghaire.

The purpose of this non-statutory public consultation is to provide notice of DLRCC's intention to carry out works under the Section 38 of the Road Traffic Act 1994.

Background




The proposed BusConnects Network Redesign includes 8 new bus services that will terminate at Dun Laoghaire Dart Station. To accommodate these new services additional bus layover spaces are required to provide for efficient bus operation.

Following review of the area by the NTA and DLRCC, Harbour Road was identified as the preferred location for these additional bus layover spaces. The scheme includes bus layover spaces, road space changes allowing turning from west to east on Harbour Road, and a new bus stop to act as a starting point for some of the routes.




Image 2.0 - Dun Laoghaire Terminus General Arrangement



Proposed Works



It is proposed to extend existing bus layover spaces by the reallocation of the adjacent existing parallel car parking spaces on the south side of Harbour Road. A new small roundabout is proposed at the entrance to the cruise terminal allowing for bus turning manoeuvres and narrowing access to the terminal providing safer pedestrian crossing points. A new bus stop with a shelter is proposed on the northern side of Harbour Road, west of the existing signalised pedestrian crossing. To provide enhanced pedestrian/cycle facilities a new 2 way off road cycle path is proposed in line with the realigned footway along Harbour Road with pedestrian/cycle priority crossing points, which ties back into existing facilities via shared areas.

Next Steps



Following public consultation and the conclusion of Section 38 process the detail design of the scheme will commence with construction anticipated to start in 2024, subject to funding allocation and successful procurement process.


