PROPOSED VARIATION NO. 1

Notice is hereby given pursuant to Section 13 of the Planning and Development Act 2000 (as amended) that Dún Laoghaire-Rathdown County Council, being the planning authority for the area, proposes to VARY the Dún Laoghaire-Rathdown County Development Plan 2022-2028 in respect of the following:

PROPOSED VARIATION NO. 1

Reason for the Proposed Variation:

Dún Laoghaire-Rathdown County Council (dlr) intends to propose a Variation Number 1 to the CDP 2022–2028 to respond to recent changes in National planning policy, namely the publication of the National Planning Framework (NPF) First Revision, the publication of Section 28 Guidelines,

- NPF Implementation: Housing Growth Requirements,
- Planning Design Standards for Apartments, and
- Sustainable Residential Development and Compact Settlement Guidelines.

The proposed variation will also update the dlr County Development Plan maps to reflect the correct boundaries of Local Area Plans adopted since the County Development Plan was made. This will include Dundrum Local Area Plan 2023, Kiltiernan – Glenamuck Local Area Plan 2025 and Old Connaught Local Area Plan 2025.

In addressing the new housing growth requirements, the variation will propose new zoning of lands.
