Safe Routes to School 'School Zone'

Post Public Consultation Report

January 2023



INTRODUCTION

Dún Laoghaire-Rathdown County Council, in conjunction with An Taisce and the National Transport Authority, is proposing to improve road safety adjacent to schools in the county as part of the NTA Safe Routes to School (SRTS) Programme. The purpose of the schemes is to make the areas immediately adjacent to the schools safer so that children can be encouraged and facilitated to walk and cycle to the schools safely.

A period of non-statutory public consultation was run for proposed traffic and road safety works outside the Holy Family National School, Dunedin Park, Monkstown Farm, Dún Laoghaire which aim to improve safety at school entrances, improve access routes to school and encourage pupils to walk and cycle.

The Scheme is being prepared in accordance with Section 38 of the Road Traffic Act 1994.

SCHEME DESCRIPTION

A Parent Survey carried out in 2021 indicated that 94.2% of the parents of children in Holy Family National School support works at the front of school that improve student safety and put pedestrians and cyclists first.

Holy Family National School, Dunedin Park has two entrances, one on Dunedin Park and one on Monkstown Grove. Dún Laoghaire-Rathdown County Council has developed proposals for public realm upgrades at both these locations.

The proposals include:

- Interventions to discourage vehicle congestion and dangerous traffic manoeuvres at the school entrances;
- Highlighting the presence of the school through carriageway colour and coloured road markings, feature bollards and traffic signage;
- Provision of additional raised pedestrian crossings;
- Provision of enhanced pedestrian space at the school entrances;
- Provision of enhanced footpaths on approach to the school;
- Upgrading of the Monkstown Grove public realm outside the school.

The design features will be consistent with those proposed nationally under the NTA Safe Routes to School Programme.

NON-STATUTORY PUBLIC CONSULTATION

Following a briefing of Dún Laoghaire Ward Councillors on Monday 27th June 2022 a period of non-statutory public consultation was carried out for a period of 4 weeks from Thursday 4th August to Thursday 1st September 2022.

Feedback was gathered through an online questionnaire, which was advertised through the following channels:

- Dún Laoghaire-Rathdown County Council website
- Dún Laoghaire-Rathdown County Council Facebook
- Dún Laoghaire-Rathdown County Council Twitter
- Dún Laoghaire-Rathdown County Council Instagram

Letters informing of the consultation were posted to eight residential properties immediately adjacent to the school's entrances on Dunedin Park and on Monkstown Grove.

At the closing date for the consultation, we received a total of 17 submissions (16 via citizens space, 1 via email and 0 by post). All 16 citizen space submissions received were unique.



SUMMARY OF FEEDBACK RECEIVED

DLR Citizen Space was the primary portal for feedback from the public during the consultation process. The responses received have been combined with the feedback received by email and by post to compile the charts below.

In summary the following preference was indicated as part of the feedback:

- 88% were in favour of the scheme proceeding as proposed at the front of school on Dunedin Park;
- 88% were in favour of the scheme proceeding as proposed at the front of school on Monkstown Grove;
- 6% did not want the scheme to proceed at the front of school on Dunedin Park;
- 6% did not want the scheme to proceed at the front of school on Monkstown Grove.

88% of respondents (15 no.) think that road safety is a problem on Dunedin Park around the Holy Family National School.



77% of respondents (13 no.) think that road safety is a problem on Monkstown Grove around the Holy Family National School.



The overall response of 94% showed that the vast majority are in favour of the progression of this project on both Dunedin Park and on Monkstown Grove.





94% of respondents support works that improve the walking and cycling routes to schools and that the proposals will provide a safer environment for school children.







There was a wide recognition that the proposals will provide a safer, more attractive environment for pedestrians and cyclists generally – 88% of respondents.



The questionnaire also gave us the opportunity to state the nature of participants' interests in the scheme.



CONCLUSION AND RECOMMENDATION


The majority of feedback received acknowledged that the proposed scheme would improve the walking and cycling routes to schools and provide a safer environment for school children. It was widely recognised that the proposals would provide a safer, more attractive environment for pedestrians and cyclists generally.

The proposed scheme received strong support with several submissions making comments on the current situation and some suggestions on how the scheme could be improved or expanded. Several comments raised by the public relate to items that are outside the scope of this scheme at this time. For more details please see the *Appendix B: Public Consultation Responses*.

The National Transport Authority have confirmed funding is available to progress such schemes in 2023. Subject to detailed design being completed and the necessary approvals and requirements being met, it is anticipated that construction will commence Quarter 2 or 3 in 2023.

It is recommended that the scheme proceeds to detailed design and construction.


Safe Routes to School 'School Zone' Concept Holy Family National School, Monkstown




Improve safety of children approaching school

	It's a shame that this scheme only encompasses 4 schools. Everything is a postcode lottery in this country.	1	The Safe Routes to School Programme was open to all schools in Ireland to apply for. 932 schools applied (almost 1 in 4 schools nationwide) and 25 schools in Dun Laoghaire-Rathdown requested participation in the Programme. The schools selected for Round 1 (current) were assessed against a range of criteria including school type, location and the school's commitment to sustainable travel. Schools that have applied this year and who have not been included in the first round of funding will not be required to reapply as they will come into the programme on a rolling basis.

Background

Scheme Details

Notification under Section 138 of the Local Government Act, 2001
