Sandyford Public Realm Potential




## **Challenges identified in Sandyford Village**

- The village centre is car dominated. The street and public realm design benefits the motorist to the detriment of other users of the space.
- Traffic travels through the village at inappropriate speeds
- There are presently no controlled pedestrian crossings points within the village
- The existing parking arrangements on Sandyford Road dissect or block the footpath making it difficult for pedestrians who have to negotiate around parked vehicles.
- Pedestrians are required to negotiate around a railing and significant change in level when moving along the foot path.
- There is a lack of cycle parking within the village
- There is a lack of definition between the civic space and the vehicle carriageway.



Car Dominated, Wheelchair users or people with buggies experience difficulties negotiating around parked cars




Obstacles in Public realm impact Pedestrian Mobility & Accessibility




## DLRCOCO have developed a series of interventions to

- Provide the community with an environment that supports the development of their long term vision for the village





- Provide infrastructure in civic space for festive events
- Provide additional cycle parking stands throughout village
